Tools: Applied Econometrics pertinent to Finance, Economics & Governance research and master the Art of Writing, Revising, & Publishing Papers.



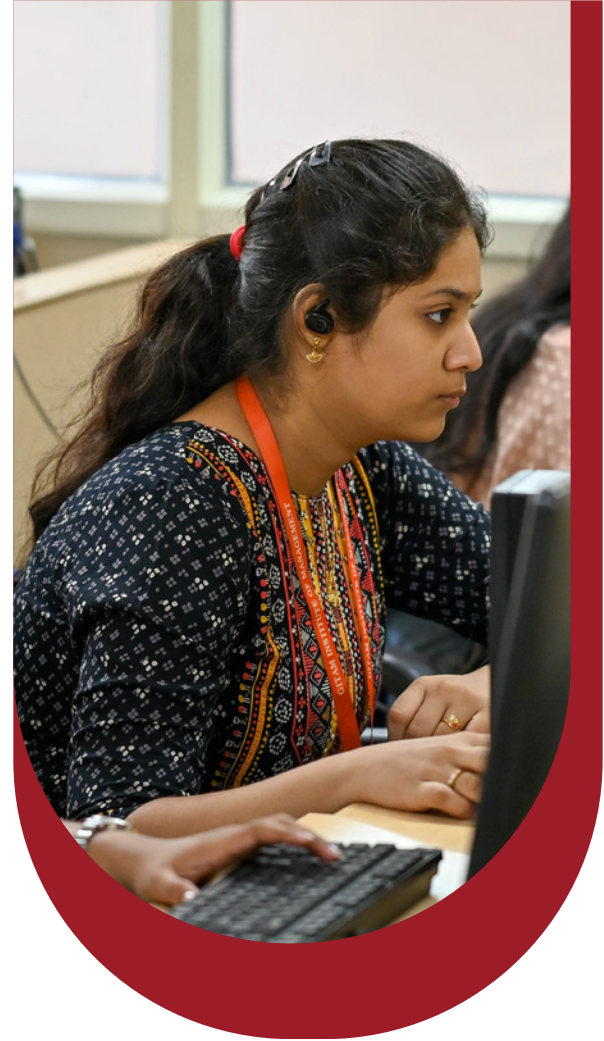

Submission of the first complete manuscript draft within 30 days of session completion, with potential presentation opportunities at upcoming conferences.

Holding a doctorate from IIT Roorkee obtained in 2012 and a Junior Research Fellowship from 2007, Dr. Kumar's interests span a wide range of topics including Corporate Finance, Supply Chain Finance, Small Business Finance, Corporate Governance, Consumer Economics, and advanced research methodologies like Systematic Literature Review and Bibliometric Analysis. His scholarly output is substantial, with more than 200 research publications in esteemed journals, including those ranked as FT 50, A*, and A in the ABDC journal rankings, covering diverse areas of finance and management. Dr. Kumar's research has been featured in leading journals such as Contemporary Accounting Research, Review of Accounting Studies, and the Journal of Service Research, to name a few.

Dr. Varnita Srivastava, a faculty at the Indian Institute of Management Shillong, specializes in Finance and Control. Holding a Ph.D. and MBA in finance-focused areas from IIT (ISM) Dhanbad, and a Bachelor of Commerce from Banaras Hindu University, she brings deep expertise in corporate finance, governance, and cryptocurrencies. With nearly 4 years of teaching experience at Christ University and Amrita Vishwa Vidyapeetham, she has also contributed significantly to academia through publications in journals like Management Decision and Managerial Auditing Journal, and as a reviewer for various respected journals.
